The testing results certificate means a document issued by a physician or a public health protection organ confirming that a RT-PCR test on SARS-CoV-2 was done with a negative result not longer than 4 days ago; the test is done on own expenses. The testing results certificate is confirmed on a template document, which is available at the MoI website.

The ordered mandatory quarantine means quarantine in accordance with § 64 letter a) in conjunction with paragraph 7 letter a) of Act No. 258/2000 Coll., on the protection of public health and on the amendment of some related acts, as amended, for a period of 14 days.
